Owen Sowerwine

About 35 people showed up for the Prudential Work Day on September 24. Lots of work was accomplished, including two new trails. Thanks to Prudential and Bob and Jane Lopp for the generous grant, again. The fencing has been put on hold until next year because of one complaint. The county rightaway will be fenced and delineated. Jean Crow from DNRC is our contact with the state, and she asked us not to talk to the neighbors; she will contact them. Walkers should be be careful where they park on Treasure Lane. Linda Winnie has been working Janet Ellis and discussed the possibility of buying a conservation easement on Owen Sowerwine. Fish, Wildlife and Parks have agreed to pay for an appraisal; Montana Land Reliance will put together a draft to submit.

Conservation

Lewis was not in attendance and but is working on a letter on how to support the high lakes project. DIL printed the Tiger Muskie letter. Linda Winnie discussed a proposed development just south of Smith Lakes, with airplane runways and houses. Linda will keep us up-to-date on this project.

<u>Conservation Awards</u>. Linda W. handed out a list of previous awards and a list of possible future candidates. Nominations needed for one award for November and two in the spring. Leo will find out more information on a Kalispell nomination. Mike moved that Flathead Land Trust and MT Land Reliance be our November awardee. Brent seconded it and it was unanimously passed. Shirley will work on this presentation.

Education Committee

On October 29 will be Teachers Who Don't Work in the Classroom Workshop at Lonepine. The Owen Sowerwine board is on hold until later in the season until committee figures out the best way to make project weatherproof. Ansley Fork talked with Kim Mitchell about participating in Project Feeder Watch and she is interested. She has a very small class (4 students) and will submit a letter proposal. Some of the board members completed cards for Rochelle to take to Dave Landstrom of Fish, Wildlife and Parks to support the 1.3 million proposed renovation of the Lone Pine Center. There was an article in the DIL on October 5 about the proposed renovation.

There will be a Publicity meeting on October 6 with the committee, DIL and Mike Moffat from Prudential.

Refuges will be discussed at the November Board meeting.

Field Trips
