The Editor's Spotting Scope

It's spring again (we knew it would get here), and again I'm in a city out-of-state for two months. Each spring I take a part-time job with the women's national bowling tournament, and in the past several years I've worked in Tampa, Cedar Rapids, Lansing, and Baton Rouge. This year I'm in Salt Lake City ... just over the hill from home.

One advantage to these annual spring treks is the bird watching in a new place: Storks and Pelicans in Florida, Mockingbirds and Night Hawks in Iowa, Northern Cardinals in Michigan and Snowy Egrets and Herons in Louisiana. And what do I find in Salt Lake City?

Seagulls! Lots and lots of seagulls, soaring over the city, meeting for lunch near the Salt Lake, resting where-ever they darn well please and acting like they own the place. And, in a way, they do.

Seagulls are very much in the history of Salt Lake City, the state of Utah and the Mormon religion. There is a large bronze figure of a seagull suspended over State Street in downtown Salt Lake City, not far from the Mormon Tabernacle. Seagulls ate their way through jillions of crickets when this area was first settled, saving the crops for the pioneers and allowing the settlement to go forward. I think it's very appropriate for a piece of art to feature a bird which had such an historical impact.

And, wouldn't you know, I don't know one seagull from another, as you may be aware if you read my last column.

have really studied these birds ... as they fly, land, sit, hunker down, disagree and talk to each other. My best guess, and two of my bird guides tend to corroborate it, is that they are California Seagulls.

If the Mormon founding fathers could make so many changes in settling this part of the west, why didn't they name these seagulls "Salty" or "Wasatch" or "Gray and White" or something else that might be more indicative or descriptive? California Seagulls? Why, oh why, you bird-naming ornithologists?

But, maybe the founding fathers tried and no one would listen. Occasionally it happens that something which needs doing just doesn't get done and we're stuck with the original, like when it's the name of a famous Seagull.

International Migratory Bird Day May 14

May 14 is International Migratory Bird Day. The big event associated with this day is the North American Migration Count, a nationwide bird count of our migrating birds.

1994 will mark the third year for this count in Montana. The count is designed to increase our understanding of the patterns and processes of migration, and to help establish an index of the number of birds in spring migrating populations.

Last year North American Migration Counts were done in 7 counties in Montana: Gallatin, Liberty, Park, Phillips, Ravalli, Silver Bow and Sweet Grass. These counts involved 69 Montanans counting 185 species of birds.

6. Attain a "higher" positive profile the in Flathead area;


Maintain biologically sound, moderate wildlife and environmental positions.

Proposed Amendments to Flathead Audubon Society Bylaws

The following proposed amendments were submitted by the Bylaws Committee and approved by the Flathead Audubon Board of Directors. The proposals will be presented for approval at the general membership meeting on May 9, 1994.

Underlined words, phrases or sentences in the proposals indicate those portions of a section that are to be added or changed.

PROPOSED AMENDMENT #1

Article II, Section 4; Heading: Meetings RESOLVED to change the first sentence to read as follows:

Notice of the annual meeting, special meetings and regular meetings, at which SOCIETY business is to be transacted, shall be given not less than seven days nor more than 30 days before the date of the meeting.

REASON: The present requirement for notices provides for not less than 30 nor more than 50 days. Since meeting notices are given through the newsletter, such lengthy prior notice is not practical or necessary.

PROPOSED AMENDMENT #2

Article II, Section 6; Heading: Meetings RESOLVED to change the first sentence to read as follows:

Members present, including at least three Board members, shall constitute a quorum at any meeting of members at which SOCIETY business is to be conducted.

REASON: The current bylaws require a quorum of either one-tenth of all voting members or 100 members, whichever is less. Such a requirement could prevent Flathead Audubon from conducting business by the membership except at the annual meeting in May. The proposal will allow those members present at a meeting to vote on items of business and provides for the Board to have representation at the meeting.

PROPOSED AMENDMENT #3

Article III, Section 1; Heading: Board of Directors

RESOLVED to change "three" to "six in the second sentence, which would then read as follows:

The Board shall include not less than six elected directors and, ex-officio with full voting rights, the elected officers of the SOCIETY.

FURTHER RESOLVED to add a third sentence to the section as follows:

Additionally, the immediate past president shall serve as a Board member with full rights and privileges.

REASON: With a membership of over 400 members, the minimum number of directors should be more representative of the size of the membership. Also, the immediate past president could offer invaluable service to the Board, based on the experience gained while in office.

PROPOSED AMENDMENT #4

Article III, Section 3; Heading: Board of Directors

RESOLVED to delete Section 3, as follows, in its entirety:

No one individual shall serve for more than one consecutive term as a member of the Board, except in the case of an individual who after one term of service on the Board is elected an officer and, as such, may serve one additional term as set forth in Article IV, Section 2, hereinafter

REASON: A term limitation for directors could create a hardship and serious loss to the Board and to the Chapter when a valuable director has to step down. It is questioned whether a limitation is even needed when, through the election process, the membership can replace a director who might not be giving good service.

PROPOSED AMENDMENT #5

Article IV, Section 1, Heading: Officers
RESOLVED to delete "Recording secretary"
and "Corresponding secretary" and replace them
with "Secretary". The section would then read as
follows:

The officers of the SOCIETY shall be a President, Vice president, <u>Secretary</u> and Treasurer, and such other officers as may be determined by the Board of Directors.

REASON: For several years, Flathead Audubon has had just one person serving as the secretary while performing the duties of both a recording secretary and a corresponding secretary. Since the system appears to be working and there is no apparent need for two secretaries, the deletion is proposed.

PROPOSED AMENDMENT #6

read as follows:

Article IV, Section 2; Heading: Officers

RESOLVED to delete the two-term limitation for the president and the three-term limitation for the other officers, and to change the terms of office from one-year to two-year. The section would then

The officers shall hold office for a term of two years following their election and until their successors take office.









REASON: As with directors, a term limitation for officers could create a hardship and serious loss to the Chapter when a valuable, experienced officer has to step down. It is questioned whether a term limitation is even needed when, through the election process, the membership can replace an officer who might not be giving good service.

A two-year term is much more advantageous than a one-year term, as the officer could gain more experience with a term of two years and be more affective for the Chapter.

PROPOSED AMENDMENT #7

Article VI, Section 1; Heading: Other Committees **RESOLVED** to change the second sentence to clarify the committee chairman's term of office and to delete the term limitation;

FURTHER RESOLVED to change "shall" to "should" in the last sentence, which pertains to the number of members on a committee. The section would then read as follows:

The President, with approval of the Board of Directors, shall appoint chairmen of standing committees who, in turn, may select their own committee members with recommendations and suggestions from the Board. Terms of office shall be for one fiscal year or until their successors are appointed. Standing committees should be composed of not less than three members.

REASON: Most of the chairmen are highly qualified individuals who bring their own levels of expertise to the Chapter. Limiting the number of terms they can serve would be a disservice to the membership. If a chairman ceases to function well, or can no longer do the job, a new chairman can be appointed by the president after the annual meeting, with apporval by the Board.

The number of members on a committee should be determined by the chairman. The Board can request the use of more members if there is an apparent need.

All approved amendments will become effective immediately after adoption.

He was a Navy brat, born in Long Beach and raised in various California towns. When his dad brought home a pair of binoculars from Japan it set the course for his life. Today he questions the wisdom of his first birdwatching project -spending hours watching English sparrows -- but he hasn't questioned his passion for birding, the environment and the outdoors in general. Brent Mitchell had to get involved with wildlife and its environs.

He got his start in the Boy Scouts, belonging to an Explorer's Troop that toured the west. In 1967, he attended Humboldt State University, studying wildlife management with a minor in range management. After college he went with the U.S. Forest Service and then to the Bureau of Land Management in Nevada as a range technician. From there he became a wildlife agent with Nevada Fish & Game (in other words, a game warden) and then got into law enforcement in Las Vegas.

"Friends wanted me to go to Montana," he said. " They raved about it. So I went on vacation in November and it was the most beautiful country I'd ever seen. I had to come back."

Law enforcement took him to Augusta, and eventually he found his way to Kalispell, where he is currently in the Maintenance Department of School District 5. Along the way he married Kay, and in 1979, she suggested that he "get out and get acquainted in

the community." He attended a meeting of the Flathead Audubon Society and, as they say, the rest is history.

Brent started as the Program Chair and then became a director. He was elected to the vice presidency and in time became the chapter's president. He took a management course and applied what he learned, to see if a participatory management style could possibly make a difference. Brent Mitchell's style made the difference.

"A lot of environmental groups tend to get mushy or emotional on issues and not so much biological. Flathead Audubon's course of action has been based more on biology and facts, rather than emotion, and that is a sound basis from which to work.

"I've always been amazed at the amount of cooperation that this group has. It's widely versatile, but the various viewpoints mesh well. I am so glad to have had the opportunity to work with these people. In giving credit where it's due, I couldn't have accomplished anything without Kay and her support."

loosestrife. Neal Brown, 837-5018.










